



Assumption Of Risk Agreement

Event: Gore 5K 4U - A Virtual Race

Event Date(s): Friday 6/26/20- Sunday 6/28/20

- In consideration of my voluntary participation in this event, I, the participant, intending to be legally bound do hereby waive and forever release any and all rights and claims for damages or injuries that I may have against Gore Mountain, the Olympic Regional Development Authority (ORDA), the State of New York, the Town of North Creek, and all of their agents, representatives, volunteers, and employees for any and all injuries to me or my personal property resulting from my participation in the event. I recognize, intend and understand that this waiver and release is binding upon me, as well as my successors, personal representatives, heirs and assigns.
- By signing this waiver and release, I acknowledge and understand that running a road/trail race is a hazardous activity that can cause serious personal injury, property damage and death. I acknowledge and understand that running a road/trail race is physically demanding and includes inherent risks. I accept responsibility for deciding if any pre-existing medical condition should limit my participation in this activity. I assume all risks associated with running in this event including, but not limited to: falls, contact with other participants, the effects of weather, traffic, and course conditions, and waive any and all claims which I might have based on any of those and other risks typically found in running a road/trail race. It is not possible to anticipate all risks that could occur during this activity, but I acknowledge and accept all such risks that could cause injury, property damage and death.
- I understand and agree that this waiver and release is to be as broad and inclusive as is permitted by the laws of the State of New York, and that if any portion of this waiver and release is held invalid, the remaining terms shall continue in full force and effect. This waiver and release shall be binding upon me, as well as my successors, personal representatives, heirs and assigns.
- By signing this waiver and release, I hereby expressly acknowledge my understanding and acceptance of the foregoing, and agree to assume all the risks of any personal injuries or property damage whatsoever that I may incur during my participation in the event. If I am signing as a parent or guardian for a child under the age of 18, I acknowledge and affirm that I have spoken with and informed the child about the risks inherent in running a road/trail race.
- Gore Mountain/ORDA reserves the right to postpone or cancel the event due to circumstances beyond their control such as a natural disaster or emergency or as required to protect the safety of participants. Gore Mountain/ORDA reserves the right to change the details of the event without prior notice.

I understand that this is a contract that is binding upon me, my heirs, and legal representatives. I, the undersigned, have read, understand and agree to the Assumption Of Risk Agreement above.
